Interaction Discovery Remote Workshop

We would like to invite you to take part in our research study. Before you decide we would like you to understand why the research is being done and what it would involve for you.

Why I am being asked to take part?

You have been invited to take part as you have relevant expertise.

Why is the study taking place?

The aim of this ideas session is to explore how designers think about the behaviour of the people they design for, and how designers influence the usability of the design. The information gathered will be used to understand how unwanted behaviours are discovered and how describing the users of an application influences the way that designers think about it, for my PhD study titled 'Interaction Discovery in Agile Development.'

What is involved in the study?

Participants will be briefed on a fictional product design project, and given some guiding principles based on the properties that the product should have.

They will be asked to suggest:

- questions that should be asked during user research
- groups that should be invited to participate in the user research
- ways that the desired properties might be lost by poor design choices

Finally, participants will be invited to provide feedback on whether the process was understandable and whether it helped the thought processes involved.

How much time will it take?

The session will take about 90 minutes, including the briefing and post-workshop feedback.

When and where is the research taking place?

The workshops will be in summer 2021, and will take place online on Microsoft Teams.

What will happen to the information?

We will record the session and take written notes. You are free to participate by audio only (switching off your webcam), or be visible to other participants if you choose to keep your webcam on. Recordings and notes will only be available to members of the research team. All personal data, including the signed consent form, will be kept separately and securely. All data collected will be anonymous, used for research purposes only, and stored securely at UCLan. The information will become part of a research thesis and may be presented at conferences and in research journal papers. You will not be named or identified in any publications about this research.

How will my data be used?

If you change your mind after the session, we will continue to use information that has already been collected. It will not be possible to withdraw your contributions as recordings are of the whole session and any written notes about the recordings from the workshop will not include names so your contributions will not be identifiable.
